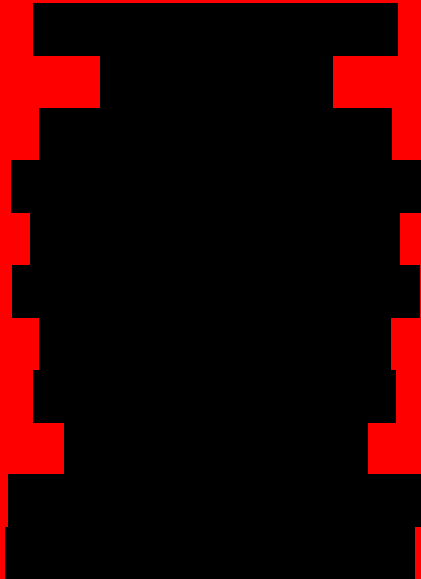

10 Tips for Sharing books with Your Child

1. Talk about the book to your child first. Talk about the front cover and the pictures. (What do you think the story might be about? What do you think is going to happen?)
2. Let your child look through the book and get a sense of the story through the pictures.
3. Read the book to your child and encourage your child to make comments about the story.
4. Ask your child to predict what will happen



next in the story before turning the page.

5. Re-read the book and suggest your child joins in when s/he wants to.
6. Ask your child if s/he would like to read the story independently.
7. Point to the words as you or your child reads.
8. Give your child plenty of time to think.
9. Try not to say that a word is wrong, but ask a question that makes them think for themselves about what they are reading, for example, "Did that make sense?"
10. Always try to be positive and give lots of praise and encouragement.

E-SAFETY - FACEBOOK

We understand that children are very keen to use social networking sites to communicate with one another and that there may be some children at school who are currently using Facebook and have created their own accounts.

We would like to make you aware of the following information which we have copied from the Facebook website:

'Statement of Rights and Responsibilities Registration and Account Security

Facebook users provide their real names and information, and we need your help to keep it that way. Here are some commitments you make to us relating to registering and maintaining the security of your account:

- You will not provide any false personal information on Facebook, or create an account for anyone other than yourself without permission.*
- You will not use your personal profile for your own commercial gain (such as selling your status update to an advertiser).*
- You will not use Facebook if you are under 13.'*

'Facebook Privacy Policy

No information from children under age 13. If you are under age 13, please do not attempt to register for Facebook or provide any personal information about yourself to us. If we learn that we have collected personal information from a child under age 13, we will delete that information as quickly as possible.'

We are sure that you will agree that the rules are clear and that any primary school child with a Facebook account has clearly broken these rules and supplied false information in setting up their account.

We urge you to have a discussion about Facebook with your child and take appropriate action where necessary. The BBC website (<http://www.bbc.co.uk/online/safety>) has links to many resources associated with e-safety, some of which we use in school. I am sure that I do not need to remind you of the potential vulnerable situation children can put themselves in when using social networking sites such as Facebook inappropriately. In creating an account without the right privacy settings children can very easily make personal information available to anyone.
